Terms and Conditions

- (i) Prices are based upon a 12 month membership contract. Recognising members circumstances change, should you wish to cancel your membership you must notify the office in writing 1 calendar month in advance. In the event of this requirement not being upheld by the member, the club reserves the right to collect any outstanding monies due.
- (ii) No additional charges apply to members who make a single payment by either cheque, debit card, direct debit, or electronic bank transfer. Payments made by monthly direct debit are subject to an administration charge.
- (iii) Single payments must be in the hands of the office staff by 5.00 pm on the last working day of the month. A late payment charge of £10 shall apply to all single payments received after this date and before the last working date of the following month.
- (iv) Completed direct debit mandates must be in the hands of the office staff by 5.00 pm on the last working day of the month. Mandates received after that time cannot be processed in time to meet the following months payment run. Given these circumstances the full payment will be recalculated over 11 months. In order to cover the additional administrative effort required to effect this change an additional charge of £10 shall apply.
- (v) Should a single payment or a direct debit mandate not be in the hands of the office staff within the timescales detailed above the member's access to the club shall be temporarily suspended until such time a single payment or a direct debit mandate is received. In such circumstances a re-joining fee of £25 shall apply and their membership will be renewed for 12 months commencing on the date of receipt of the single payment or the direct debit mandate. Any member who has still not paid their monies during this additional 14 day extension shall be considered to have resigned their membership.
- (vi) Family membership covers 2 adults and all children under 18 and any under 25 adults in full time education who are normally resident at the same address. The membership category applied to the children and/or the under 25 adults will be restricted to the category of membership selected by the adults.
- (vii) Members wishing to join the Club shall be expected to comply with the prevailing Club's rules. A copy of these rules are available from the office.
- (viii) The Club deems that the member has viewed and complies with The Waiver of Liability by the signing of a renewal or application form.
